ADDENDUM 6

The Illinois Department of Healthcare and Family Services (HFS) is issuing Addendum 6 to amend the original Request for Proposals (RFP) for the above referenced project, as issued by this office on February 5, 2010 and is now considered a part thereof.

Addendum 6 is being issued to publish information regarding a meeting between Potential Bidders and potential subcontractors, including potential vendors in the Business Enterprise Program (BEP) and vendors providing mental health and alcohol and substance services. Businesses in the healthcare industry (providers, case management agencies, health IT and other support businesses), including those that are owned by minorities, females or individuals with disabilities, are invited to attend. Also, not-for-profit organizations for persons with disabilities may qualify as BEP vendors. The Department has arranged a meeting to provide an opportunity for potential BEP vendors to gain information about subcontracting opportunities from Potential Bidders for the Integrated Care Program.
